I Appeals by Students

The Senate is charged by the *Universities (Scotland) Acts* with a duty to superintend the teaching of the University. This is understood to include examining. The Senate has authorised the establishment of Faculty Appeals Committees to hear appeals in the first instance, as specified in the Code of Procedure for Appeals to a Faculty Appeals Committee.

A student may further appeal from the decision of the relevant Faculty Appeals Committee to the Senate.

Any appeal giving all the grounds of that appeal must be despatched in writing to the Clerk of the relevant Faculty, or to the Clerk of Senate, as appropriate, within 14 days of the intimation to the student of the decision against which he or she is appealing.

Students are advised to consult the Clerk of the relevant Faculty before lodging an appeal to the Faculty Appeals Committee and the Head of the Senate Office, before lodging an appeal to the Senate Appeals Committee.

The Code of Procedure for Appeals to a Faculty Appeals Committee and the Code of Procedure for Appeals to the Senate are set out in that section of the University *Calendar* entitled 'University Fees and General Information for Students', which is available either from the Faculty Office or The Registry enquiry office in the University.

III UNDERGRADUATE ENTRY TO FACULTY OF MEDICINE

Before applying for admission to the Faculty of Medicine, all applicants should consult the most recent edition of the University's Undergraduate Prospectus. The Prospectus sets out the normal qualifications required for admission, describes the application procedure, summarises the degree regulations and courses offered, and gives general information about the University. It is available in most U.K. schools, or it may be obtained from The Registry, University of Glasgow, Glasgow G12 8QQ.

Information regarding the higher degrees of Doctor of Medicine, Doctor of Dental Surgery, Doctor of Philosophy, Master of Science (Medical Science), Doctor in Clinical Psychology (DClinPsy), Master of Public Health (MPH) and Master of Nursing (MN) is given in the 'Graduate Studies' section of the University *Calendar*.

IV DEGREES OF BACHELOR OF MEDICINE AND BACHELOR OF SURGERY (Old Curriculum)

These regulations apply to students who commenced study prior to October 1996.

For the Degree of MBChB under the New Curriculum *see* page Med.9.

ORDINANCE

The Degrees of Bachelor of Medicine and Bachelor of Surgery are governed by Ordinance 387 (General No. 14) which came into force in October, 1962. The relevant provisions of this Ordinance are as follows:

- I. The Degrees of Bachelor of Medicine (MB) and Bachelor of Surgery (ChB), hereinafter called 'the Degrees', may be conferred by the University. The Degree of Bachelor of Medicine shall not be conferred otherwise than with the Degree of Bachelor of Surgery, and vice versa.
- II. (1) The curriculum shall extend over such period as the Senatus Academicus, with the approval of the University Court, may determine.
(2) A candidate shall spend at least three academical years in study in the University. The remaining period of the curriculum may be spent in any other University or Medical School approved for this purpose by the Court after consultation with the Senatus.
- III. The Senatus, with the approval of the Court, may from time to time make regulations:
 - (a) determining the subjects of study and the courses of instruction;
 - (b) determining the subjects of examination and the number of divisions in which the examinations for the Degrees shall be arranged;
 - (c) determining the conditions under which a candidate may be exempted in whole or in part from instruction or from instruction and examination in any subject for the Degrees;
 - (d) for such other purposes as the Senatus may deem expedient for the operation of this Ordinance.
- IV. Provided that, where any such regulation introduces into the curriculum any additional subject of study, or removes from the curriculum any subject of study, or alters the duration of the curriculum, the Court shall communicate it to the General Council, and that any representation made thereon by the General Council within two months of the date of communication shall be taken into consideration by the Court before such regulation is approved.
- V. The Examiners for the Degrees shall be the Professors, Readers and Lecturers who conduct courses qualifying for graduation in Medicine and Surgery in the University, and such other internal and additional Examiners as the Court shall appoint; provided that every candidate shall be examined in each subject by at least two Examiners of whom one shall not be a Professor, Reader or Lecturer in the University.
- VI. Notwithstanding the provisions of this Ordinance the Senatus may, during a period not exceeding seven years from the date on which this Ordinance shall come into operation, permit a candidate to offer himself or herself for the Degrees of Bachelor of Medicine and Bachelor of Surgery under the regulations previously in force.

SUPPLEMENTARY REGULATIONS

GENERAL

1. Length of Course

The course of study for the Degrees of Bachelor of Medicine and Bachelor of Surgery shall extend over not less than five academic years.

2. Exemption

A candidate may be granted such exemption from courses and examinations as may be approved by the Senatus on the recommendation of the Faculty of Medicine provided that he or she spends not less than three academic years in study at the University.

3. Departmental Instructions

Students shall be required to comply with such departmental instructions as are prescribed by the Head(s) of Department(s) in charge of the course concerned. Such instructions may require students: to attend specified lectures, tutorials, laboratory or practical sessions, field courses, examinations and other events; to provide themselves with such books, equipment and other materials as are necessary for the course; to submit items of work, including essays, dissertations and project reports, by such dates as may be instructed. All such instructions shall be given to the students in writing at the beginning of the course concerned. Reasonable notice of any alteration to them will also be given. A student who fails to comply with departmental instructions may be refused enrolment in and admission to degree examinations in the subject.

ORDER OF STUDY AND EXAMINATION

4. Courses and Examinations

The courses and examinations of the curriculum shall be as follows:

First, Second, Third and Fourth Year Courses:

Please refer to *Calendar* entry for 1995–96.

Students who commenced study before 1996 will continue to study the courses described.

Students who commenced study in October 1996 or thereafter will follow the curriculum governed by Resolution 340 (*p. Med.9*).

Fifth Year Courses:

Clinical Medicine, Clinical Surgery, Child Health, Obstetrics and Gynaecology, General Practice.

Final Professional Examination

June:	Written:	Surgery and Medicine, Child Health.
	Clinical:	Surgery, Medicine, Child Health.
November:		Second diet of examination. Written and clinical examinations in Obstetrics and Gynaecology are held at the end of each twelve week block.
June:		Second diet of examination.

5. Progress

A candidate may not proceed to any stage of the curriculum until he has completed, or has been granted exemption from, the courses and examinations of the preceding stage.

6. Periods of Residence in Hospital

Candidates shall be required to undertake periods of residence in hospital as an integral part of the course of study.

COMBINED COURSE**7. Degree of BSc**

Selected candidates may be admitted at the discretion of the Faculty of Science to study for the degree of B.Sc. Such candidates will be re-admitted to the medical course provided they resume their studies in the session immediately following that in which they completed or terminated their studies in the Faculty of Science.

8. Degree of BSc(MedSci)

Selected candidates who have completed three years of the MBChB degree may be admitted at the discretion of the Faculty of Medicine to study for the degree of BSc(MedSci).

EXAMINATIONS**9. Conduct**

Examinations in all subjects shall be conducted in writing and where appropriate, practical, clinical and oral examinations shall also be held.

10. Class Records

The work done by a candidate throughout the course of study in the subject of an examination may be taken into account by the examiners.

11. Entry and Re-entry

A candidate must present himself or herself in all the subjects of the appropriate Professional Examination on the first possible occasion after completing the prescribed course of study. A candidate who has failed in the examination in any subject of a Professional Examination must present himself or herself for re-examination in that subject on the first occasion for which he or she is eligible. On each occasion of taking a Professional Examination a candidate must present himself or herself in all of the subjects of that examination in which he or she has not already passed. The Faculty of Medicine may exceptionally permit a candidate to postpone entry to all or any of the subjects of a Professional Examination.

12. Passes

A candidate may be granted a single pass in one or more of the subjects of a Professional Examination. In the Final Professional Examination a candidate will not be granted a pass in any subject unless he or she has attained the minimum mark required for a pass in each of the component parts of that subject.

13. Class Certificates

A candidate may not enter for any Professional Examination unless the Professor or Lecturer in charge of the course has certified that he or she has satisfied the requirements of that course. A candidate who for this reason has not been permitted to enter for any examination will be deemed to have failed and to have gained no marks on that occasion. A class certificate shall normally be valid only during the academic year in which it is issued but in special circumstances its validity may be extended by the Dean after consultation with the Head of Department. Students who are required to obtain a new class certificate shall carry out such further studies and pass such examinations as the Head of the Department may require.

To be eligible to sit the first diet of the Final Professional Examination, a candidate must have gained class certificates in all subjects of at least three of the four parts of the Final Professional Examination, where the four parts are:

- (i) Surgery.
- (ii) Medicine.
- (iii) Child Health.
- (iv) Obstetrics and Gynaecology.

14. Absence

A student who is absent from classes due to illness should inform the Faculty Office as soon as possible. (Clinical students should also inform the unit secretary.) Absence of more than one week must be supported by a medical certificate.

Absence from either a class or a Professional Examination due to illness requires a certificate to be received by the Faculty Office within 7 days of the date of the examination, otherwise the candidate will be deemed to have sat and failed the examination and gained no marks on that occasion.

The Faculty may make further enquiries of the doctor who issued the medical certificate, through the Medical Officer of the Student Health Service, who may require the student to attend for medical examination.

15. Referred Study

A candidate who has failed in an examination in any subject will not be readmitted to that examination until he has fulfilled any conditions of further study which the Faculty of Medicine may prescribe.

16. Distinction

A candidate may be awarded a pass with distinction in any subject of a professional examination in which he has shown special merit on the first occasion of presenting himself for that examination.

17. Honours and Commendation

A candidate who has shown special merit as indicated by his or her performance in the First, Second, Third, Fourth and Final Professional Examinations may be awarded (i) Honours or (ii) Commendation. Only the grades gained on the first occasion of offering or being deemed to have offered a subject will be included in the aggregate for this purpose.

EXCLUSION OF STUDENTS

18. Grounds

A candidate whose conduct or progress is considered not to be satisfactory may be excluded from further instruction and examination for the degree of MBChB. A candidate will normally be excluded:

- (a) if he or she fails to pass all subjects of the First Professional Examination after two attempts;
- (b) if he or she fails to pass at least three subjects of the Second Professional Examination after a second attempt, or if he or she fails any outstanding subject of the Second Professional Examination after a third attempt;
- (c) if he or she is unable, or will be unable, to sit the Final Professional Examination before the completion of his or her sixth session in the study of Medicine;
- (d) if he or she fails to complete the Final Professional Examination after three attempts.

A student whose studies have been so terminated shall have the right of appeal to the Appeals Committee of the Faculty.

19. Electives

In the case of the Junior and Senior Electives which are intended to permit students to undertake, in or furth of Glasgow, the study in some depth of any aspect of medical science or the practice of medicine, including general practice, which has the approval of the Dean, a candidate shall be required to provide written evidence that his or her attendance and work during the periods of his or her approved electives have been satisfactory.

V DEGREES OF BACHELOR OF MEDICINE & BACHELOR OF SURGERY

The Degrees of Bachelor of Medicine and Bachelor of Surgery for students commencing their studies in October 1996 are governed by Resolution 430 which took effect on 12th February 1997.

- I. The Degrees of Bachelor of Medicine (MB) and Bachelor of Surgery (ChB), hereinafter called 'the Degrees', may be conferred by the University. The Degree of Bachelor of Medicine shall not be conferred otherwise than with the Degree of Bachelor of Surgery, and vice versa.
- II. The curriculum for the Degrees shall extend over not fewer than five academic years of full time study.
- III. The regulations for the Degrees shall be as stated in the schedule hereto.
- IV. The examiners for the Degrees shall be the Professors, Readers and Lecturers whose subjects are appropriate and such other internal and external examiners as may be appointed by the University Court on the recommendation of the Faculty of Medicine and of Senate.
- V. Notwithstanding the provisions of this Resolution, the Senate may permit any student whose course of study was begun before the date on which this Resolution comes into force to offer himself or herself for the Degrees under the regulations previously in force (see *Calendar* entry for 1995–96) provided that, except by dispensation of the Senate, no such permission will be granted after 7 years from that date.

REGULATIONS

The contents of the undernoted regulations for the Degrees are subject to the approval of the Senatus and the University Court.

GENERAL

Length of Course

The course of study for the Degrees shall extend over not less than five academic years.

Exemption

A candidate may be granted such exemption from courses and examinations as may be approved by the Senate on the recommendation of the Faculty of Medicine.

Instructions

Students shall be required to comply with such instructions as are prescribed by the Faculty of Medicine. All instructions shall be given to the students in writing at the beginning of the year, course component or study block. Reasonable notice of any alteration to them will also be given. A student who fails to comply with instructions may be refused enrolment in and admission to degree examinations.

Assessment of Independent Learning

A Medical Independent Learning Exercise (MILE) will be undertaken by students as part of their course work during the Whitsun term of the first year. Students who fail to satisfy the examiners will re-sit a MILE in September. A student who fails to pass the MILE at the second attempt will normally be excluded.

Assessment of Special Study Modules

The means by which a Special Study Module will be assessed and the weighting of each component of assessment, will be specified in the course documentation.

The final result awarded for each module will be either Distinction or Pass or Fail.

A student who has been awarded a Fail at the conclusion of the module, will be reassessed over the summer vacation by means of written work, the extent and nature of which will be determined by the Supervisor in consultation with the Course Co-ordinator.

A student will be required to obtain a pass in 6 out of 7 Special Study Modules.

Electives

The Junior and Senior Electives are intended to permit students to undertake, in or furth of Glasgow, the study in some depth of any aspect of medical science or the practice of medicine, including general practice, which has the approval of the Dean. A candidate will be required to provide written evidence that his or her attendance and work during the periods of his or her approved electives have been satisfactory.

Certificate of Basic IT Competence

Every candidate must normally obtain the Certificate of Basic IT Competence in his or her first year of study in order to progress to subsequent years of study.

ORDER OF STUDY AND EXAMINATION

The curriculum will consist of three main components:

- The Integrated Core
- Vocational Studies
- Special Study Modules

FIRST YEAR

The Integrated Core (Round 1 – ‘Cells to Societies’)

Round 1 which is based on a broad overview of medicine, will consist of a series of Problem Based Learning sessions. There will normally be two such sessions during each week and the year will be organised as a series of blocks, each of which will normally last for five weeks. Studies undertaken during the Problem Based Learning sessions will be supported by learning resources which may include, *inter alia*, lectures, tutorials, visits, demonstrations, laboratory sessions and seminars.

In addition to the Integrated Core, students will also undertake Vocational Studies during which they will be introduced to patients and to the care of patients in the community and in hospital.

FIRST YEAR DEGREE EXAMINATIONS

The following examinations will take place during the Whitsun Term.

- An assessment of independent learning (MILE)
- A written examination consisting of 2 papers (MBChB I)

Performance in assessed coursework in Year 1 will contribute 20% towards the first diet only of the written examination MBChB I.

A candidate who fails to satisfy the examiners in any of the above examinations will be required to resit at the next diet.

SECOND YEAR

The Integrated Core (Round 2 – ‘Molecules and Tissues’)

The second year of the curriculum will continue the Integrated Core and Vocational Studies. In addition, students will select from a list of options, one Special Study Module which will be of 5 weeks’ duration. This will be undertaken during the second half of the Candlemas Term.

The Integrated Core will continue the pattern of Problem Based Learning sessions and resource sessions established during Year I.

SECOND YEAR DEGREE EXAMINATIONS

The following examinations will take place during the Whitsun Term:

- An objective structured clinical examination (OSCE II)
- A written degree examination consisting of 2 papers (MBChB II)

Performance in assessed coursework in Year 2 will contribute 20% towards the first diet only of the written examination MBChB II.

A candidate who fails to satisfy the examiners in any of the above examinations will be required to resit at the next diet.

THIRD YEAR

The Integrated Core (Round 3 – ‘Clinical Systems’)

The third year of the curriculum will consist of a continuation of the Integrated Core and Vocational Studies. Two Special Study Modules each of 5 weeks’ duration will be selected from the list of options. In addition, students will undertake a period of elective study of a minimum of 4 weeks’ duration at the conclusion of the third year.

THIRD YEAR DEGREE EXAMINATIONS

The following examinations will take place during the Whitsun Term:

An objective structured clinical examination (OSCE III)

A written degree examination consisting of 2 papers (MBChB III)

Performance in assessed coursework in Year 3 will contribute 20% towards the first diet only of the written examination MBChB III.

A candidate who fails to satisfy the examiners in any of the above examinations will be required to resit at the next diet.

FOURTH YEAR

The Integrated Core (Round 4)

The fourth year of the curriculum will consist of a series of clinical attachments based in hospitals and the community. Two Special Study Modules, each of five weeks duration, will be selected from the list of options. These will occur consecutively as a ten week block. In addition the students will undertake a period of elective study of a minimum of 4 weeks duration which may be an extension of a Special Study Module.

FOURTH YEAR ASSESSMENT

There will be no professional degree examinations in this year. Students will be assessed on their performance in the integrated core. The following forms of assessment will take place:

end of attachment assessment

a portfolio of clinical cases (one per week for the duration of the clinical core) reviewed by the educational supervisor

a written examination to be held during the first month of Year 5

Students who fail to reach the required standard will be interviewed by the

Progress Committee which will have the authority to require a period of referred study to be undertaken during the summer vacation between Years 4 and 5 or to delay the date of the final examination.

FIFTH AND FINAL YEAR

The Integrated Core (Round 5)

The Final year will continue the series of clinical attachments commenced in Year 4. As in Year 4, two Special Study Modules will be undertaken, each of five weeks duration, occurring consecutively as a ten-week block. The third term will include a period of work experience in which the student will shadow a Junior House Officer for a period of two weeks.

FINAL EXAMINATION

To be eligible to sit the first diet of the Final Examination a student must have performed satisfactorily in the following:

- eight attachments
- a portfolio of 50 clinical cases approved by the educational supervisors
- six out of seven Special Study Modules
- a Junior and a Senior Elective

The following degree examinations will take place during the third term of the Final year:

- a written examination of two papers (MBChB V)
- an objective structured clinical examination (OSCE V)
- an objective structured long examination record (OSLER)

In order to fulfill the requirements for the award of the degree, all students will undertake a period of work experience shadowing a Junior House Officer for the two weeks immediately following the formal degree examinations.

A candidate who fails to satisfy the examiners in any of the above examinations will be required to resit and pass at the next diet.

HONOURS AND COMMENDATION

A student who has shown special merit in the Special Study Modules, the portfolio of written cases, the clinical examination (OSCE V) and the written examination (MBChB V) may be awarded Honours or Commendation at the discretion of the Final Board of Examiners.

COMBINED COURSES

Degree of BSc(MedSci)

At the end of the third year of the medical curriculum, selected students may be permitted to undertake as an intercalated course, the degree of BSc(MedSci) Honours. Such candidates will normally resume the medical curriculum in the session immediately following that in which they completed or terminated the course leading to the degree of BSc(MedSci).

Degree of BSc

At the end of the third year of the medical curriculum, selected candidates may be admitted at the discretion of the Faculty of Science to study for the degree of BSc Honours. Such candidates will be re-admitted to the medical curriculum provided they resume their studies in the session immediately following that in which they completed or terminated their studies in the Faculty of Science.

EXAMINATIONS

Entry and Re-entry

A candidate must present himself or herself in the appropriate Degree Examinations on the first possible occasion after completing the prescribed course of study. A candidate who has failed any part of a diet must present himself or herself for re-examination on the first occasion for which he or she is eligible. The Faculty of Medicine may exceptionally permit a candidate to postpone entry to a Degree Examination.

Class Certificates

A candidate may not enter for any Degree Examination unless the Faculty of Medicine has certified that he or she has satisfied the requirements of the course. A candidate who for this reason has not been permitted to enter for any examination will be deemed to have failed and to have gained no marks on that occasion. A class certificate shall normally be valid only during the academic year in which it is issued but in special circumstances its validity may be extended by the Dean after consultation with the Progress Committee. Students who are required to obtain a new class certificate shall carry out such further studies and pass such examinations as the Faculty of Medicine may require.

Attendance

Students are required to participate in all elements of the course.

Absence

A student who is absent from any component of the course for up to 5 term-time days excluding Saturday or Sunday is required to provide the Medical School office with a self certificate in the case of illness. A certificate signed by a doctor

is required for absence of 6 days or more duration. Where the cause is other than illness a letter should be submitted to the Medical School office.

Persistent absence will normally result in a report to the Progress Committee.

Where a student is absent from a degree examination owing to illness, a certificate signed by a doctor must be submitted to the Medical School office within 7 days of the absence.

PROGRESS

The Faculty Progress Committee will have the authority to set aside the regulations governing exclusion and to permit a student to repeat a year of the course. In considering each case, the Committee will have the right to take the student's attendance record into account.

Exit Degree

A candidate who has completed the first three years of the course and who, for good reason, is unable to complete the course, may be eligible for the award of the exit degree B.Med.Sci. (*See page Med.19 of the Calendar*).

EXCLUSION OF STUDENTS

Grounds

A candidate whose attendance, conduct or progress is considered to be unsatisfactory may be excluded from further instruction and examination for the degree of MBChB.

A candidate will normally be excluded if he or she fails to pass after two attempts any of the following:

- (a) MBChB I or the MILE
- (b) MBChB II or OSCE II
- (c) MBChB III or OSCE III

In addition a candidate will normally be excluded

- (d) If he or she is unable or will be unable to sit the Final Degree Examinations before the completion of his or her sixth session in the study of Medicine.
- (e) If he or she fails to pass the Final Degree Examination after three attempts.
- (f) If he or she fails to pass 6 out of 7 Special Study Modules.

A student whose studies have been so terminated shall have the right of appeal to the Appeals Committee of the Faculty.

VI DEGREE OF BACHELOR OF SCIENCE IN MEDICAL SCIENCE

The Degree of BSc(MedSci) is governed by Resolution No. 414 of the University Court which came into effect on 21 February 1996. The relevant provisions are as follows:

1. The Degree of Bachelor of Science in Medical Science BSc(MedSci) may be conferred by the University of Glasgow as an Ordinary degree or as a degree with Honours in one or more principal subjects. The degree may not be awarded honoris causa tantum. The degree shall not be recognised as a primary qualification conferring the right of registration on the Medical Register.
2. Every candidate for the degree, unless granted a concession or exemption under Regulations made under this Resolution, must attend during not less than four academic sessions courses of instruction in the University of Glasgow in the subjects of study prescribed by Regulations made under this Resolution and must pass the examinations similarly prescribed.
3. The examiners for the degree shall be persons in the University of Glasgow who conduct courses qualifying towards the degree and such additional examiners as the University Court may appoint, on the recommendation of the Senate.
4. The Senate may, with the consent of the University Court, make regulations governing the award of the degree.
5. The regulations for the degree shall be as stated in the schedule hereto.

SCHEDULE OF REGULATIONS

The following Regulations are made in terms of Sections 3 and 4 of Resolution No. 414 of the University Court.

1. Preliminary Requirement

Every student admitted as a candidate for the degree must also be a candidate for the Degree of MBChB or have obtained the Degree of MBChB not more than five years before the date of admission as a candidate for the Honours degree.

2. Attendance

Every candidate for the degree, unless granted a concession or exemption under Regulation 2 for the Degree of MBChB, must attend in the University of Glasgow during not less than three academic years courses of instruction in the classes of the first three years of the curriculum for the Degree of MBChB, and pass the degree examinations prescribed for these courses, normally at the first attempt.

In addition to fulfilling the requirements set out above, every candidate must

pursue advanced studies for at least one year in the University of Glasgow in one of the following principal subjects of study:

- Anatomical Sciences
- Biochemistry
- Clinical Medicine
- Genetics
- Microbiology
- Molecular and Cellular Biology
- Parasitology
- Physiology

or in such principal subjects of study in the University of Glasgow as may be approved by the Senate on the recommendation of the Faculty of Medicine.

The year of study in one of the principal subjects for Honours may be intercalated after the third year of study or added on at the end of the course leading to the Degree of MBChB, subject to the approval of the Faculty of Medicine.

3. Admission

Admission to the Honours study depends on satisfactory completion of studies in the year or years preceding admission and satisfaction of any entry requirements prescribed for a particular Honours course. Candidates must apply to the department(s) responsible for the courses to which they seek admission with a statement of their results achieved to date. Admission is at the discretion of the head(s) of department concerned but a candidate refused entry may submit for the consideration of the Faculty of Medicine any special circumstances bearing on his or her case.

4. Conditions of Study

- (a) During the minimum period of study required for graduation by a candidate that candidate may not undertake any professional training or other occupation without the approval of the Faculty.
- (b) Candidates may not attend courses outwith their curriculum in another Faculty without the permission of the Faculty of Medicine.
- (c) Candidates are required to comply with instructions issued or approved by the Head of the Department in which courses are conducted relating to such matters as attendance at specified lectures, tutorials, laboratory or practical sessions, field courses, examinations and other events, the provision of necessary books, equipment and other materials for courses, submission of items of work such as essays, dissertations and project reports by particular dates. Such instructions must be given in writing at the beginning of the course concerned and reasonable notice of any alteration must be given.

5. Class Certificates

The grant of a class certificate entitling a candidate to take degree examinations

is conditional on regular attendance on and due performance of the work of the relevant course in accordance with departmental instructions. Class certificates in the Faculty are normally valid for the diets of examination in the academic year in which they were granted but (a) on cause shown their validity may be extended by the Faculty; (b) class certificates held by a candidate cease to be valid if the candidate is required to discontinue study for the degree.

6. Progress in Studies

The Faculty with the approval of Senate may require any candidate to discontinue study for the degree.

7. Appeals

Appeals against decisions of a department or the Faculty affecting a candidate should be made to the Faculty Appeals Committee in accordance with the procedure set out in the University *Calendar*.

8. Honours Examination

The written papers and other components of the Honours examination, all of which must be taken at a single diet of examination, shall be as prescribed in the syllabus of Honours examinations. The examiners at their discretion may further examine candidates orally. A dissertation on an approved topic may be substituted for any one of the relevant papers with the permission of the Head of Department concerned. Any such dissertation must be submitted by the beginning of Whitsun term in the year in which the Honours examination is taken.

No candidate who has taken the Honours examination at any diet in a Principal subject may subsequently retake the examination in the same subject without the permission of the Senate.

Honours are awarded in three classes but the second class may be divided into upper and lower divisions. The names of successful candidates within each class or division shall be arranged in alphabetical order. A candidate who has not been placed in any class may be recommended by the examiners for the award of an Ordinary degree.

The standard of Honours examinations and the criteria for distinguishing the classes and divisions of classes shall be recommended by the Faculty to Senate for approval.

In assessing a candidate's performance for the purpose for the award of Honours the examiners shall have regard to the merit of his or her performance in the Honours examinations and may also have regard to the merit of his or her previous performance in the MBChB Course.

Where a candidate who has duly completed the work in his or her Honours subject is prevented by illness medically certified or by other good cause from taking or completing the Honours examination:

- (i) If the candidate has completed at least two-thirds of the prescribed Honours examination the examiners, having received reports on his or her class work, have imposed if they think fit a test or tests, written or oral, in lieu of the uncompleted part of the written examination and having considered all the evidence available to them, may recommend the award of the appropriate class of Honours degree or an Ordinary degree; or
- (ii) If a candidate has completed a lesser or no part of the Honours examination the examiner shall receive reports on his or her class work and consider all the evidence available to them and if in their opinion the candidate would have reached at least the standard expected of candidates who are awarded Honours of the second class may recommend the award of an unclassified Honours degree. If in their opinion the candidate would not have reached that standard they may recommend the award of an Ordinary degree.

The consent of a candidate to the award shall be required for the award of such an unclassified Honours or Ordinary degree on the first occasion only on which it is recommended. If the candidate refuses the recommended award in the first occasion, or if the Examiners recommend neither an unclassified Honours nor an Ordinary Degree, then the candidate will be deemed not to have presented himself or herself for examination.

VII DEGREE OF BACHELOR OF MEDICAL SCIENCE

A Resolution to govern the Degree of Bachelor of Medical Science is set out below. This Resolution has still to receive the approval of the University Court.

1. The Degree of Bachelor of Medical Science may be conferred by the University of Glasgow. The Degree shall not be recognised as a registerable qualification carrying the right to membership of the General Medical Council or the General Dental Council.
2. Every candidate for the Degree must have been a candidate for either the Degrees of MBChB or the Degree of BDS and must:
 - (a) have attended at the University the courses of instruction for the Degrees of MBChB or BDS over a minimum of three academic sessions.
 - (b) have passed the examinations of the 1st, 2nd and 3rd years of the MBChB curriculum or BDS curriculum.
3. A student who has successfully completed the first three years of the course of study leading to the Degrees of MBChB or BDS may, with the permission of the Dean of the Faculty of Medicine, transfer to these regulations and graduate with the Degree of Bachelor of Medical Science.

4. A candidate may be recommended for the award of the Degree of Bachelor of Medical Science:
 - (i) if he or she is unable or will be unable to complete the Final Professional Examination before the completion of his or her sixth session of study for the Degrees of MBChB or BDS *OR*
 - (ii) has indicated in writing to the Dean of the Faculty of Medicine that he or she no longer wishes to pursue a curriculum leading to the Degrees of MBChB or BDS.

Such a candidate, if graduating with the Degree of Bachelor of Medical Science may not be a candidate either for the Degrees of BSc(MedSci) or BSc(DentSci) or for the Degrees of MBChB or BDS, of the University of Glasgow on a future occasion.
